DIRECTIONS

Plymouth Office - 40 Industrial Park Road, Plymouth, MA 02360 • 1-508-746-8600

From Route 3:

- Merge onto US 44 West via Exit 7 towards Taunton / Providence, RI
- Take the first exit toward MA 80 / Cherry Street / North Plymouth
- At the top of the ramp, turn left onto Commerce Street
- At the set of lights by the Exxon station, turn right onto Nicks Rock Road
- After approximately half a mile, turn right onto Industrial Park Road
- Turn left into 40 Industrial Park Road, proceed up the drive towards the back of the building, bear right into the private patient parking lot (gate will open automatically), and enter building through main lobby doors

Reference: Our office is located in the same building as the RMV

E. Wareham Office - 3119 Cranberry Highway (RT 28 / US 6), Suite 3, E. Wareham, MA 02538 • 1-508-759-1360

From I-495 / Route 25:

- Take Exit 2 onto Route 28 towards Onset / Wareham
- Stay on Route 28 (US 6) East for approximately 2 miles, passing through 6 traffic lights
- Turn right into 3119 Cranberry Highway parking lot

From the East and Cape Cod, from the Bourne Bridge:

- Take Exit 3 to the rotary in Buzzards Bay and follow Route 28 (US 6) west towards Wareham
- Go through the second rotary and stay on Route 28 / US 6
- Turn left into 3119 Cranberry Highway parking lot, approximately 1 mile after the second rotary

Reference: Our office is located in the new Jordan Plaza, next to Meineke Muffler and across from Barnacle Bill's Restaurant

Mashpee Office - 133 Falmouth Road (RT 28), Mashpee, MA 02649 • 1-508-477-7833

From Falmouth / Mashpee, Route 28:

- Turn left into 133 Falmouth Road after the Rotary on Route 28

From the Bourne Bridge, Route 28:

- Head towards Falmouth and take the Route 151 Exit towards Mashpee
- Go 3/4 of the way around the rotary onto Route 28 and turn left into 133 Falmouth Road after approximately 1.5 miles

From Plymouth, US 6:

- Take Exit 2, turn right onto Route 130, and continue straight until the road ends at Route 28
- Turn right at the traffic light onto Route 28 and turn right into 133 Falmouth Road after approximately 3/4 of a mile

From Outer Cape, US 6:

- Take Exit 5, bear left at the end of the ramp, and follow Route 149 south until it ends at Route 28
- Turn right onto Route 28 and then turn right into 133 Falmouth Road after approximately 3 miles

From I-495:

- Take Exit 4 and turn left (from the South) or right (from the North) onto Route 105 / South Main Street
- Turn left into 12 West Grove Street and look for the white clapboard building to the right

From the Middleboro Rotary, Route 28:

- Turn right at the second light onto Route 105 and turn right into 12 West Grove Street
